

United Nations General Assembly Resolutions with references to 'General and Complete Disarmament' (1946 – 2015)

Researching and consolidating 'General Assembly Resolution Sessions' data from the un.org website, this list summarises annual UNGA committee meetings and resolutions since the organisation's first session in 1946 to present day (2015), that make references to 'general and complete disarmament'. Under the umbrella and goal of 'general and complete disarmament', topics discussed ranged from the regulation and limitation of small arms, to complete nuclear disarmament, to disarmament in space and on the sea bed. However farfetched the goal may seem, the data show that there is awareness within the international community, and more importantly, a consensus for an international effort towards achieving 'general and complete disarmament'.
